ORDINANCE 0408 SERIES 2015

AN ORDINANCE OF THE TOWN OF NORWOOD BOARD OF TRUSTEES ELECTING THE EXCLUSIVE LOCAL REVIEW PROCESS FOR LIQUOR LICENSE SPECIAL EVENT PERMIT APPLICATIONS AS AUTHORIZED BY COLORADO SENATE BILL 11-066 (CRS§ 12-48-107(6)) .

WHEREAS, pursuant to Articles 46, 47, and 48 of Title 12 of the Colorado Revised Statutes, the Town of Norwood, Colorado ("Town") possesses the authority to license and regulate, concurrently with the state of Colorado, the service and sale of alcoholic beverages within the Town, and

WHEREAS, during its regular legislative session in 2011, the Colorado General Assembly adopted Senate Bill 11-066 ("SB 11-66") which amended Article 48 of Title 12, CRS, governing liquor license special event permits, and

WHEREAS, SB 11-66 grants local liquor licensing authorities the option to assume exclusive local control over and responsibility for the issuance of said special event permits within their respective jurisdictions,

NOW, THEREFORE, BE IT ORDAINED BY THE TRUSTEES FOR THE TOWN OF NORWOOD, COLORADO, THAT:

(a.) Pursuant to CRS § 12-48-107(5)(a), the Board of Trustees or its authorized agent, acting as the local licensing authority ("Authority"), elects not to notify the state licensing authority to obtain the state licensing authority's approval or disapproval of applications for special events permits.


(b.) The Town Clerk shall report to the Colorado Liquor Enforcement Division, within ten (10) days after the Authority issues a special event permit, the name of the organization to which the permit was issued, the address of the permitted location, and the permitted dates of alcohol beverage service.


(c.) Upon receipt of an application for a special event permit, the Town Clerk shall, as required by CRS §12-48-107(5)(c), access information made available on the state licensing authority's website to determine the statewide permitting activity of the organization applying for the permit. The Authority shall consider compliance with the provisions of CRS § 12-48-105(3), which restricts the number of permits issued to an organization within a calendar year to fifteen (15), before approving any application.

(d.) A special event permit may be issued only upon a satisfactory showing by an organization or a qualified political candidate that the organization or political candidate is temporarily occupying premises other than the regular premises of such organization or candidate during special events such as civic celebrations and that members of the general public will be served during such special events.

(e.) Each application for a special event permit shall be accompanied by an application fee in an amount equal to the maximum local licensing fee established by CRS § 12-48-107 (2).
